Pre-meeting student link update: Academic Aspiration – Apertura Programme

HE talked to the governors about the Apertura Programme which is run across the Trust for year 10, 11 and 12 students who have been selected by the Ebacc. subject leads and heads of house. It is a three-year programme based on a Tripos system covering three strands: political, natural science and linguistic and social. The programme is constituted of lectures, supervision sessions and a project in year 12 based on the theory of knowledge.

Three year 12 students spoke to the governors on how they have found the programme. They have had discussions groups covering topics such as medical ethics and women's rights and having the opportunity to speak freely in a way that they wouldn't do in a class environment. The students also found that they engaged in subjects that they wouldn't have expected to enjoy.

In response to the governors' question regarding how success of the scheme is measured, HE replied that success falls under the theory of change, i.e. students are enjoying topics they wouldn't have considered, they are broadening their knowledge and learning different themes and subjects, and ultimately in can help bring about university success.

RH updated the governors on the latest Academic Aspiration data for the school as outlined in the CHHS Summer Report. The students had coped really well with the exams and staff were quietly confident. The year 10 and 12 students were in the middle of their mock exams following an intense period of getting them in to good learning and revision habits. An update will be given in September once the GCSE and A Level results have been received.

Q. PB There has been a big gap between exams for the year 13s. How was that for the students?

A. HE It was ok. It helped with revision to have a couple of days when students could come in and meet teachers during study leave. We also had more students come in to study as well as meet teachers; the study centre was full of year 12 and 13s. Students were also directing themselves into break out rooms for group study. Students also came into socialise which was possibly as a result of the last couple of years.

Q. AJ Are the students still getting offers in? **A. HE** Yes, and they are aiming really high, but we will have to wait and see. It is predicted that more students will need to go through clearing this year, but there have been a few offers from prestigious universities.

2.1 Laurus AC report – CHHS Summer 2022

Q. PB Were any of the students affected by the issues regarding the leaking of the chemistry paper?A. HE It was out of our hands but students were upset.We advised them not to worry and they calmed down after the exam board made a statement.

AB spoke about attendance and explained there are problems currently around persistent absence. Attendance was at 96% but dipped by 2.5%, so we are looking at driving those figures back up. Some students haven't come out of the pandemic well and poor attendance is habit forming so can be difficult to break. Year 10 is the group with the lowest attendance with much school-based anxiety. School is looking at new, creative approaches to addressing this including changing the rhetoric around what is said in assembly and encouraging conversations between form tutors and students.

Q. PB What about unauthorised absences? **A. WS** More unauthorised absences have been allowed post covid due to not being able to attend certain events, such as weddings etc, before. However, there is going to be a hard message in September to get students back in.

Q. PB Do you still have attendance officers?A. WS The Education Welfare Service has been trimmed

back so they just focus on the legal side. We offer a supportive approach if needed but would call on them if we needed a home visit. However, they wouldn't go out for a visit for, say, a 91% attendance.

AB then spoke about behaviour and exclusions explaining that our number of exclusions are better that the national average. E Warrington's BLIP programme has been really effective in bringing down the numbers of exclusions for SEND students. Looking at the comparison tables, our year 9 is the most challenging with the most C2 and C4 sanctions. Not having had a full year in school due to the pandemic has played a significant part in school not having had the opportunity to set behavioural expectations and good routines. The majority of year 9s are very good but there are a handful we are struggling with where we have had to have parents in and 10 of whom have been on report. We are hoping for an improvement next year with the cohort taking their options and classes being mixed.

We have also been resetting expectations on uniform and jewellery with a no tolerance policy which has been really effective.

School has also been cracking down on lates with a member of senior leadership taking designated lates detentions, which has seen the numbers dropping off.

We have also reviewed the Time Out passes and replaced them with Step Out passes so that the language being used around these is being considered. Each pass will have instructions for staff which are specific to that child so that situations involving these students are managed based on the individual's needs.

We'll have a big push on all these issues in September and speak to staff on the INSET day and students in assembly so that we get back into consistent good, habits.

Q. AJ Will you be communication this to parents? **A. DB** Yes. We need a point of reference for gravitas and support.

Q. MK Do you expect any push back from parents? **A. AB** No, they are very supportive and fed back positively when we implemented the tighter rules around uniform and jewellery.

Q. AJ Could we have feedback on how this is going in September?

A. AB Yes.
